## February 13 Meeting on Cyber-Bullying

Join AAUW for our February program featuring **Julie Nicolai**, teacher, writer, speaker and expert on bullying.

The author of *Road Map through Bullying: Effective Bully Prevention for Educators*, Julie has been fighting to eradicate bullying for years. As a facilitator and member of the Bully Task Force in her school district, she created a code of conduct form addressing bullying behaviors specifying appropriate levels of interventions and responses from teachers, administrators, and students. Julie is sought out for guidance on bully issues by students, parents, teachers, and administrators. She was recently interviewed for the Glen Ellyn News and the Geneva Republican. She was also interviewed as a teacher representative in a Hollywood-produced documentary entitled "Bullies 101".

Julie's program provides practical and useful advice for parents, grandparents and community members - as we continue to support AAUW's longstanding leadership addressing issues of sexual harassment in schools.

In 2011 AAUW published, "Crossing the Line: Sexual Harassment at School" which presents new evidence on sexual harassment and now addresses cyber-bullying. What are some of these "new tools" of bullying? What can we do as a community to help our children navigate the

pitfalls of social media – where harassment can be sent to hundreds with the click of "enter"? Let's work together to understand bullying and cyber-bullying and its impact on our community and its youngest members.

## Paycheck Fairness Act Reintroduced

On January 23, Senators Barbara Mikulski (D-MD) and Rosa DeLauro (D-CT) re-introduced in the Senate the Paycheck Fairness Act, which addresses the wage gap between men and women.

The bill, S. 84 seeks to amend the Fair Labor Standards Act of 1938 and require employers to prove that differences in wage are the result of differences in merit, not gender. It also prohibits retaliation against employees who file claims of wage discrimination, and allows victims of wage discrimination to seek punitive damages for lost wages.

In a press release, Senator Mikulski said "The Paycheck Fairness Act ensures that women will no longer be fighting on their own for equal pay for equal work."

The Paycheck Fairness Act was first introduced in 2009 but failed to get the necessary 60 votes to pass in the Senate. Last year, the act was filibustered by Senate Republicans in June.

Last week a bipartisan group of senators announced the reintroduction of the Violence Against Women Act (VAWA). This is essentially the same bipartisan bill that the Senate passed in April 2012 to improve VAWA programs and ensure all victims get the services they need. Because the House didn't pass this version of VAWA before the end of 2012, we must renew our efforts today to protect victims of domestic violence.

**Your passionate advocacy got this bill passed last year. Let's keep the momentum going: Urge your senators to cosponsor and vote for VAWA!**

Since its enactment in 1994, VAWA has saved lives and saved money. Though the programs continue to run, the current authorization expired almost two years ago. VAWA reauthorization is long overdue and should be a priority in the 113th Congress.

S. 47 is a well-crafted bill with strong bipartisan support. AAUW is particularly pleased that S. 47 includes campus safety provisions which will ensure that institutions of higher education have comprehensive procedures in place to address domestic violence, dating violence, sexual assault, and stalking. **Urge your senators to cosponsor VAWA and move this bill forward!**
