The ABCs of Sex Education: Making Informed Choices

Wednesday • April 13 , 2016 • 7 pm

Elmhurst Public Library

The ABCs (Abstain, Be faithful, & use Condoms) is a knowledge and skills-based approach to reducing the incidence of HIV, other STDs, and unwanted pregnancies through behavior change.

The group works in Kenya training community educators to teach HIV prevention and sex education. Training includes anatomy, sexual and reproductive health, STD information, and resources.

Attendees discuss topics including serial monogamy versus concurrent relationships and its impact on disease transmission.

More than 70,000 Kenyans have been taught by ABCs' trained community educators since 2008. Increased HIV testing and condom purchasing has been reported in areas following ABCs training, as well as reductions in student pregnancies.

Please come to learn more about this challenging topic.

Our speaker is Kathy Tate-Bradish, Founder & Executive Director of The ABCs of Sex Education. Kathy holds a degree in German secondary education from the University of Illinois, and has taught middle school English in Austria and middle and high school German in Illinois and at the American School in London. She also holds a law degree from Northwestern University, and passed the bar in 1981.

Kathy has been volunteering in Kenya since 2004. In 2008 she started a multi-day training program based on the curriculum she developed that is now known as The ABCs of Sex Education.

Member Profile - Jeanette Flaningam

During the discussion/question time after our March meeting speaker completed her presentation about her mother's experiences as a member of the WACs (Women's Army Corps) during World War II, our branch member, Jeanette Flaningam, shared that she had been a member of the WAVES at that same time. Here is her story.

Jeanette grew up in Champaign-Urbana where her father was Dean of Men at the University of Illinois. In 1942, when she was 19 years old and a sophomore student at the university she chose to work towards a Bachelor of Science in Law. As a student in this program, she began courses in the law school beginning in her junior year. Because a great majority of male students had been drafted and were serving in the WWII military at that time, there were only 12 students in her law school class, half of which were female. Jeanette completed her undergraduate studies and earned her Bachelor's Degree in 1944.

Following graduation and responding to a desire to "serve her country" and to the posters that said, "Uncle Sam Wants YOU!" — Jeanette enlisted in the Navy in the WAVES (Women Accepted for Volunteer Emergency Service).

Jeanette did her basic training in officer training school at Smith College in Massachusetts entering the Navy as a Midshipman, being promoted to Ensign after training and reaching the rank of Lieutenant Junior Grade. Her first post was at the Dept. of the Navy in Washington, D.C. where she worked in Communications Security. Then she was transferred to the U.S. Naval Base in Key West, Florida, where she was assigned as the Assistant Welfare and Recreation Officer until the war ended on VJ Day (Victory in Japan) and she received her discharge orders.

Jeanette returned to Law School at the University of Illinois on the GI Bill in a post war class that had grown to 200 students and earned her J.D. Degree. She married her husband, Tom Flaningam, in 1953 after he returned from Army service in the south Pacific. They had met as young people at their church in Champaign. Jeanette and Tom moved to Elmhurst and raised a family of two daughters, Jill and Karen. Jeanette's primary work was at home with her children during their early years and she also taught Business Law and Accounting on a part-time basis at Elmhurst College. Then to enhance her credentials and prepare herself for full-time employment when her girls were in school all day, she attended Northern Illinois University in DeKalb and earned an MBA. She then worked at Continental Bank in the Estate Planning Department until her retirement. Her husband, Tom, died in 1998.

Jeanette has been a member of AAUW Elmhurst Area Branch since 1955 which makes her one of the Branch's Honorary Life Members. She chose AAUW because she appreciated the focus or the organization on intellectual stimulation and interesting program topics. And she's still an active member for those same reasons.




Wheaton-Glen Ellyn Used Book Sales

Announcements from the Bylaws & Policy Committee

At the March 2nd Elmhurst Area Branch Board meeting, the Board voted to amend our branch's governing By-laws as recommended by the Bylaws and Policies Committee. Copies of the amended By-laws are being emailed to all members along with this April newsletter. These amendments fall into two categories:

Amendments that do not require the approval of our members because they were required by AAUW National.

- Title – changed to Bylaws of the American Association of University Women Elmhurst Area Branch – the legal name per the IRS.
- Article I (Name and Governance) - clarified that our bylaws should not conflict with federal, state or local laws. Also added compliance to AAUW Policies.
- Article II (Purpose) - clarified that the branch purpose is to support the program and policies of AAUW in addition to the purposes.
- Article III (Use of Name) – added required wording on the Proper Use of Name and Logo.
- Article IV – (Membership and Dues) Added wording about branches and comparable AAUW-Affiliated entities. Clarified that partner members may belong to various AAUW entities. Added wording about how AAUW National determines the annual dues.
- Article VI – Changed title to Organization. Added term Noticed business meetings to signify our membership business meetings which have a notice sent out. Added phrase that elected and appointed officers shall facilitate and promote the purpose and mission of AAUW.
- Article XI (Meetings). Changed business meeting to Noticed Business Meetings
- Article XIII (Loss of recognition) rephrased to match AAUW National wording.
- Article XVII (State or Multi-State Organizations) and Article XVIII (Additional AAUW Entities) both added as mandated by AAUW National

Amendments recommended by the Bylaws & Policies Committee that must be approved by our branch members.

•Amendments to Article VI (Officers) and VII (Board of Directors) based on recommendations from AAUW National to governance “best practices” standards.

§ The recommended amendments focus on the composition of our branch's Board of Directors. Our board recommends adding the position of STEM Advocacy to the Board as an appointed position as this is a key focus of the National and State organizations.

§ AAUW National recommends that the Board consist of 2/3 (or more) of elected positions and 1/3 (or less) appointed positions. To maintain that ratio in Articles VI and VII with those recommendations, our branch's By-laws, if approved, will provide that the Director Public Policy, formerly an appointed position, will be elected to serve on the Board of Directors.

•Other changes were made to reflect our current practices, and/or to clarify terminology between our By-laws and the AAUW National Bylaws and/or to align terms between our Policies and Bylaws. Examples are:

§ Paid Life members shall still pay the state and branch dues as already specified in our polices

§ Clarified that the current President should be on the Nominating Committee.

§ Clarified that whenever possible, one program vice president and half of the elected officers shall be elected each year to ensure overlap and continuity.

§ Clarified that AAUW required contacts for administration and finance are the President and the Finance Director.

§ Clarified that the monthly programs are events and noticed membership meetings are business meetings.

§ Clarified the role of the Program committee as already discussed in the Policies.

• These recommended changes would meet the “best practices” recommendation of AAUW National and, if approved by our members and our state branch, would take effect next year.

We will be asking our members to support the recommended changes to our branch By-laws at the April 13th Annual Business meeting. The By-laws and Policies Committee members, Sarah Caltvedt, Jan Summers and Marcia Lagerwey, will all be at the meeting to talk about the changes and answer any questions and address any concerns. Thank you all and we hope to see you in April!
