NATIONAL AAUW ELECTION - 2021

This spring, AAUW members will be asked to vote on amendments to the Public Policy Priorities and Bylaws, in addition to electing members to the National Board of Directors. Voting will take place from April 7 to May 17, 2021.

OPEN MEMBERSHIP BYLAWS AMENDMENT

The Bylaws Amendment change proposes the elimination of the degree requirement for membership. To further inform and explain the issues surrounding this proposed amendment, articles will be included in the next three branch newsletters. Statement from the AAUW National Board of Directors: “The AAUW National Board of Directors strongly supports elimination of the degree requirement for membership and will put the requirement up for a membership vote this spring. This important change is a critical step in bringing AAUW’s bylaws and membership requirement in line with our mission of advancing equity for women and girls. While AAUW is fiercely committed to the educational attainment of all women, given our commitment to inclusion, this is simply the right thing to do.

Proposals to eliminate the degree requirement for membership have come before the membership for vote a number of times. The Board feels very strongly that while the degree requirement made perfect sense at AAUW’s inception, this requirement is now counter to our mission, and limits our ability to build the capacity needed to increase our impact as an organization.

Statement from the AAUW Racial and Social Justice Working Group: As members of this working group, we are passionate about ensuring that AAUW become more diverse and inclusive. Eliminating the educational requirement for membership is an essential step toward that goal: If we are truly committed to advancing equity for all, we need to become more equitable ourselves. While the requirement may have made sense early in our history, by today’s standards it is perceived as elitist, exclusionary and out of touch.

To remain relevant, every organization must evolve. It is essential that we send a loud and clear message that we welcome all who share our values and goals — regardless of whether or not they hold a college degree.

Education remains a top priority for AAUW, of course, and we continue to advocate for opening doors to schooling, training and career opportunities to advance economic security for women and girls. But we will be better positioned to do our work by welcoming a more diverse membership. We should not be turning people away.

In Memory of Kathy Salzano

Kathy Salzano died Feb.6. She was one of our newest members, having joined with a Shape the Future membership last spring. Some of you may have encountered her at one of our Zoom socials in the summer. Kathy was an ESL teacher and had previously taught Spanish as well at Elmhurst College and COD. She was devoted to her students and to social justice. Cancer camp for kids, the Unitarian Church, and the Addison Township Democratic Organization were some of the organizations where she was active. The mother of three grown children, Kathy is also survived by her husband Antonio and other family.

Editorial on Repeal of the Parental Notice of Abortion Act (IL HB 2467)

The Illinois Parental Notice of Abortion Act (PNA, 1995) went into effect in 2013 and required parents or other adult family member in a girl's home to be notified by medical personnel 48 hours before a girl can have an abortion. This law is burdensome to medical staff but can be prohibitive and actually dangerous to a pregnant teen.

Most teen girls seeking abortions have had discussions with their parents or guardians. But in too many homes, telling parents can lead to 1) notifying the family members who sexually abused the girl; 2) homelessness when the girl is thrown out of her home; 3) further abuse in a troubled family; or 4) being forced to have an unwanted baby against a girl's will.

Supporters of the PNA point out that the girl can override the parental notice requirement by going to court by herself. She can locate credible legal how-to, cut school (and the school notifies her parents), find transportation (think public transportation or rural areas), and stand before a judge and discuss the most intimate details of her life. And, during all of this, she is increasing the medical risks of her abortion by waiting.

An Illinois teen can, without parental knowledge, go through labor and delivery, give a child up for adoption, and obtain surgeries including a Cesarean, among other rights. Why not an abortion?

There is no medical basis for the PNA. In fact, going through with a pregnancy and delivery in Illinois is more dangerous than having an abortion especially for a black girl who faces six times the risk of mortality than white girls for herself and almost three times the risk of seeing her infant die.

IL HB 2467 is the repeal of the Illinois Parental Notice of Abortion Act and it is coming up soon in the Illinois House. Representatives need to hear about your views on this bill. Even if you think your representative supports abortion, let them know that you do, too.

We know that Governor Pritzker will sign the bill if passed but there is a strong minority pressure to ensure the survival of the PNA. Please tell others about calling their representatives, too.

I worked as the Pregnancy Counselor in a Job Corps Center for (Impoverished) Women 16-21 in the 1970's and I know the consequences of unwanted pregnancies to these young women. I know they still exist.

Half the Sky's ICDI PROJECT UPDATE

Working in cooperation with the Interfaith Community for Detained Immigrants (ICDH) we have given:

- 161 snack bags for immigrants' bus travel
- 15 wallets - 12 of which had \$20 added
- 10 men's COATS

ICDI is using the snack bags because every day there are 5-10 immigrants coming through the bus terminal. Seventeen AAUW members and friends have contributed to this project.

Additionally, more AAUW members have expressed interest in supporting this project in the future. We will send alerts when more bags are needed.
