This month's program will tell the story of young Willa raised by her father, a Klan member, and how she evolves throughout her journey in the novel, *Down the Steep* by A.D. Nauman, a friend and colleague from Northeastern Illinois University. Hear her personal story and how it "some of it" aligns with this page turner.

A.D. Nauman is an award-winning author and educator whose second novel, *Down the Steep*, was published by Regal House in 2023. Her short fiction has appeared in *Chicago Quarterly Review*, *Willow Springs, TriQuarterly, Roanoke Review*, and many other journals. Nauman's work has been recognized in *Best American Short Stories* and the *Pushcart Prize* anthology, produced by Stories on Stage, broadcast on NPR, and granted an Illinois Arts Council Literary Award. Her first novel, *Scorch*, was re-released in an ebook StoryBundle in 2019.

AAUW opposes McMahon's nomination and invites you to join us in taking action to protect public education and students' civil rights. A Senate confirmation hearing for McMahon is expected in the next few weeks. <u>Please ask your senators to thoroughly examine McMahon's record and intentions for the Department of Education</u>.

National Conference for College Women Student Leaders

As many of you have heard the sponsorship for the National Conference for College Women Student Leaders (NCCWSL) Conference is changing. NASPA-Student Affairs Administrators in Higher Education is assuming the sponsorship of NCCWSL as of 2025. Check out their website. Public Policy Update

Karen Kortsch and Ken Olson AAUW Illinois Public Policy Co-Chairs

The Illinois lame duck session of the 103rd General Assembly just finished on January 7th, and on January 8th the inauguration of new legislators and the start of the 104th General Assembly took place. Karina's Bill, which would allow guns to be removed from domestic abusers, finally passed the Senate during the 103rd GA (President Harmon held it up in the Spring pending a supreme court case decision); and the house concurred. As I write this, the new session has only begun so we don't yet have information on what bills will be introduced this session. When Jenni, our lobbyist, gets a list together, Ken and I will get regular updates on what bills we may want to support. There may be witness slips to file or letters to legislators to be written. We will get that info to you through the public policy mailing list and hopefully people on that list will pass it along to their chapter members. There will probably be a lot of bills to consider and we will choose to focus on those that align with our AAUW values and Public Policy priorities.

The Public Policy priorities are currently being revised by the National office, and you should have received an email titled Dues Change and Governance Proposals – Comment Now! That email includes a link to review and comment on Public Policy priorities updates. If you did not receive the email please go to the AAUW website and look for this information. Also make sure you are subscribed to receive email notices from the National office

Here is the most recent news from the Public Policy Co-Chair:

Hello, a disturbing update to share:

The Administration is quickly attacking the environment/efforts to combat global warming, equity, education, the infrastructure, health programs, worker safety and much, much more. Here is an initial list of Executive Orders from the White House, with more to come. Several state AAUW's are looking to support state legislation to provide as much protection as possible. We are fortunate in Illinois that our legislature has proactively taken action already. We are currently reviewing proposed legislation to identify bill we will support to protect or implement AAUW priorities.

February 26, 2025 — <u>Miss Hokusai</u> about a 19th century Japanese woman artist in anime format 1:30 and 7:30


March 5,2025 —_XTrillion an all-women crew of scientists researches micro plastics in the Pacific Ocean
